## Congress of Minnesota Resorts

### Message from the CMR President

We had a great turnout for the CMR's Day on the Hill; the best ever with over 50 people attending. We met with a lot of new and returning Representatives and Senators. We even met with Governor Dayton who I feel is very supportive of our issues.

Some of our key issues that we brought up at the Day on the Hill are listed below. I'll sum them up in a nutshell.

**Flexible Learning Calendars: HF 627/SF 410:** education is a top priority for CMR members, but the CMR feels that the legislature balanced all the state's interests when it decided to require schools to start after Labor Day. Flexible learning schedules that do not include additional instructional days are simply trying to get around the post Labor Day start date.

**Restricted Plumbing Licenses: HF 632/SF 411:** Since the window to obtain a plumbing license has closed, this means that a new resorter will not be able to apply for one. This bill would allow transferring that license to the new owner of the resort.

**Sprinkler Systems in Cabins SF 297/HF 460:** This one I will go into a little more detail so everyone is up to speed. The State of MN is looking to adopt, through rule making, the International Building Code which has mandatory sprinklers in all new and remodelled buildings, including single family dwelling units. This would be devastating to our industry as it would add on an average \$20,000 per cabin. Not including the infra structure to supply sufficient water to each cabin. It would cost a 10-12 cabin resort over a quarter million dollars to have sprinkler systems throughout, not including any maintenance and inspections. There isn't a bank around that would finance something like this, that adds no extra income to our bottom line. According to the National Fire Protection Association, a homeowner has a 99.45% chance of survival if their home has a working smoke detector. Adding a fire sprinkler requirement increases survival rate to 99.85%. I feel that we all take the necessary measures to ensure the safety of our guests without adding sprinklers.

We also included support for continuing funding for Explore Minnesota Tourism the CMR supports efforts of the MN DNR and others to control the spread of aquatic invasive species.

I would like to thank our Legislative Committee for doing another fine job with the Day on the Hill. Thanks also to Joel Carlson and his assistant, Tami LeFavor for setting up all the meetings. A special thanks to everyone that contributed items to the Resort Show that we had set up at the Capitol. It gave our resort industry some added exposure, especially to those that we were not able to meet with. Last but not least, a big thank you to those of you that took the time to make the trip to the Capitol. Without member participation it wouldn't have been very successful!

Mark your calendars for the Spring Workshop that will be held in Bemidji, March 28<sup>th</sup>. This is always a good way to start out a new season! Hope to see you there!

If you only want to join the mailing list and not have access to the Archives, do NOT click on "Join the Group" – INSTEAD, click on the phrase "Join the Mailing List Instead." You should get an approval message in your email box in 1-2 days.

### To Join the Web Site Access Version by Sending an Email Message to the Group

Follow the instructions above and DO click on "Join the Group." You will be led through a series of steps to either enter your current Yahoo! ID or register for a new one. ### To Join the Web Site Access Version by Using the Membership Wizard

Go to the Yahoo! Groups Membership Wizard at <http://groups.yahoo.com/memwiz>. You will be led through a series of steps to either enter your current Yahoo! ID or register for a new one. Once signed in, make sure the email address where you are receiving messages from the Resorters Group appears in the Membership Wizard dialog box. If it does not appear, add it via the link provided. You will be sent a verification email to that address to assure that you own it. Once you have a verified email address, continue with the steps in the Wizard. 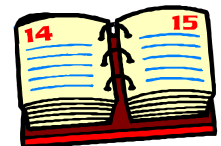
