Explore Minnesota Tourism Council Update

CMR members,

The Explore Minnesota Tourism Council, in our June meeting, re-affirmed the goal of a \$20 million annual tourism budget. Given the history and outcome of previous legislative sessions, it is necessary to look at different options to achieve this goal.

One of the options discussed was a statewide tax on lodging; arts, entertainment and recreation; and food and beverage sales tax was proposed.

This generated a mixed response at the meeting relative to timing for this coming legislative session and to the overall economic situation. We agreed that, if needed, organizations would take this back to their stakeholders for feedback and further discussion.

We are looking for feedback based on the following alternative funding option for Minnesota tourism:

Alternative Funding Option for Explore Minnesota

1/4 percent on lodging industry (e.g., \$2.50 tax on \$1,000) - \$4 million statewide 1/4 percent on amusement/recreation industry (e.g., \$0.25 tax on \$100)- \$4 million statewide 1/8 percent on eating/drinking (e.g., \$0.125 tax on \$100)- \$8 million statewide

This funding option would replace funds from the general fund and allow us a mechanism to grow based on performance. It is estimated that this would have generated approximately \$16 million statewide in FY06 (most recent figures available).

We also agreed to pursue diversifying our funding with proceeds from the Minnesota Lottery revenue in lieu of sales tax. This would capture only increases, does not impact LCCMR funding, and generates anywhere from \$1 to \$2 million per year. We will do further research on the Minnesota Lottery mechanics.

Please let us know your thoughts on Alternative Funding Option for Explore Minnesota as described above. We need to hear back by September 29, 2008. We would also appreciate any thoughts on funding alternatives for the future.


